Revised Guidelines for the Cash Incentives to the Faculty for Publishing Research Papers with effect from 01.07.2013

The following are the guidelines for the sanctioning of cash incentives to the faculty for publishing research papers in various international and national journals and conferences with effect from **01-07-2013**.

International Journals:

- For the paper published in IEEE or IEE or ASCE or ASME the cash incentive will be Rs. 15,000/-.
- For the paper published in Thomson Reuters listed journals (available at http://ip-science.thomsonreuters.com/cgi-bin/jrnlst/jloptions.cgi?PC=D) the cash incentive will be Rs. 6,000/-.

International Conferences:

Any International conference by name will be treated as International Conference in true sense, if it is organized by well known societies like IEEE, IEE, ASCE, ASME, Elsevier, etc.

- 1. If the international conference is organized by any reputed societies or any reputed institutes (like IITs, IISc, NITs, etc.), then the cash incentive for publishing the paper in this type of conference will be Rs. 2000/-.
- 2. If the international conference is organized by any reputed organizations (like deemed universities, private organizations), then the cash incentive for publishing the paper in this type of conference will be Rs. 1500/-

National Journals:

Any National Journal by Title will be treated as National Journal in true sense, if it has **minimum age of 5 years and has the policy of announcing Impact Factor**. This criterion can be relaxed if the Journal is published by reputed society like IE(I), IETE, CSI, etc;

1. If the national journal is peer-reviewed, containing ISSN number, making the basic comments of reviewers available to authors and also the journal is brought out in the form of hard copy, then **the cash incentive for publishing the paper in this type of journal will be Rs. 1500/-.**

National Conference:

- 1. If the national conference is organized by any reputed societies or any reputed institutes (like IITs, IISc, NITs, etc.), then the cash incentive for publishing the paper in this type of conference will be Rs. 1000/-.
- 2. If the national conference is organized by any reputed organizations (like deemed universities, private organizations), then the cash incentive for publishing the paper in this type of conference will be Rs. 500/-.

General Information:

1. Any claim for monetary incentive for publishing a research paper must be accompanied by two hard copies of the published paper along with the reviewer comments if available.

2. Any publication with more than four authors is not eligible for incentives.

3. Only those papers, where the author's affiliation belongs to the college (i.e. GPREC) will be eligible for incentive.

- 4. Papers published in journals, which are available *only on-line* are not eligible for incentives.
- 5. If the first author is from GPREC, then the author will be entitled for full cash incentive.
- 6. If the second author is from GPREC, then the author will be eligible for only 50% of cash incentive.
- 7. The papers published based on dissertation work by M.Tech students are not eligible for any cash incentive.

- 1. Faculty members are requested to send two copies of all relevant documents (Xerox copy paper, registration receipt, travel and hotel receipts etc.) along with the covering note through the concerned HOD to the R& D Cell for the approval.
- 2. If the faculty members attend the conference/workshop without presenting the paper then the sponsorship will be given for one time only in an academic year.
- 3. If the faculty members attend the conference/workshop and present the paper by 'n' times then the sponsorship will be given for 'n' times in an academic year.
