The Class work for the academic year 2020-21 for **II,III & IV B.Tech students** commenced on 24.08.2020. The last date to pay the tuition fee with a fine is already over. In spite of several reminders, **students whose names are enclosed with this circular, have not paid the tuition fee. Hence their names are to be deleted from the respective nominal rolls with effect from 23.10.2020** and they will be re-included only after they pay the tuition fees along with a **special fine of Rs.500/-**. **During the period in which their names remain deleted they will be marked absent and they will not be allowed to attend the ONLINE classes.** Hence the students are required to pay the fees along with fine at the earliest to see that they will not loose much of attendance and avoid the risk of getting detained.

The details of the tuition fee & other fees for the academic year 2020 – 2021 are furnished below

1. Students admitted in 2019 have paid tuition fee of Rs 80,000/- for the academic year 2019-2020 but the state Govt. has fixed tuition fee of Rs 70,000/-. The excess tuition fee of Rs 10,000/- paid by the students is adjusted in the tuition fee for the academic year 2020-2021.Hence they are required to pay Rs 60,000 + other fees of Rs 5,850 for the academic year 2020-2021.

2. ***Students of II B.Tech are required to note that, the decision on the fee structure fixed by the AP state Govt. is pending with the honorable court. Hence students admitted in 2019 must be prepared to pay any excess tuition fee to be fixed by the AP State Govt. at a later date.***

3. Students can pay the tuition fee by choosing any one of the following :-

- Through challan (which are available in the office) into the college **SB A/C No. 152110011010667, Andhra Bank, GPREC Branch, Kurnool, IFSC : ANDB 0001521**, and submit a copy of the challan in the main office.
- Through a **DD favoring M/s G.Pulla Reddy Engineering College, payable at Kurnool** preferably drawn on Andhra Bank by writing the details like name, class, branch, Roll number etc., on the reverse side of the DD, and send it to the Principal, G.Pulla Reddy Engineering College (Autonomous), Nandyal Road, Kurnool – 518 007.
