ORDER:

1. The AICTE, New Delhi and Government of A.P have accorded approval to the above college during the academic year 1984-85 vide (ref.1) and (ref.2) read above. The college was affiliated to the S.K.U, Anantapur till the academic year 2009-10. JNTU Anantapur (JNTUA) in its order cited in (ref.3) has permitted transfer of affiliation to JNTUA of any existing Engineering / MBA&MCA colleges falling under the jurisdiction of JNTUA and affiliated to some other University. The college while submitting a No Objection Certificate from the Registrar, S.K.U, Anantapur (ref.4) has sought **Permanent Affiliation** from JNTUA from the academic year 2010-11. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider grant of **Permanent Affiliation** from the academic year 2010-11 vide Procs. (ref.5) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (ref.6) read above. The Standing Committee for Affiliation, of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting **Permanent Affiliation** from the academic year 2010-11 vide (ref.7) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report within one month from the date of extending Permanent Affiliation

1. Teacher Student Ratio should be improved in Civil Engineering & Electrical & Electronics Engineering Departments as per AICTE norms.
2. Academic Regulations should be inline with JNTUA regulation w.e.f the academic year 2010-11
3. Laboratory equipment for "Thermal Engineering and Energy Systems" PG programme should be improved.

The University Grants Commission, New Delhi vide ref (8) read above, has conferred Autonomous status to G.Pulla Reddy Engineering College from 2006-07 to 2011-12. The college continues to act as an autonomous institute, as per the norms and guidelines of UGC, for the remaining period i.e till the academic year 2011-12, while being an affiliated college of JNTU Anantapur.

However, the college is instructed to rectify the above deficiencies and submit a compliance report within one month, failing which the Permanent Affiliation will be withdrawn.

The Permanent affiliation shall be subject to the following conditions:

1. The management shall follow the norms of AICTE and the rules of the affiliation of JNTU University Anantapur in all aspects.
2. Anti-ragging measures to be taken strictly in accordance with UGC regulations on curbing the menace of ragging in Higher Educational Institutions, 2009 (F.1-16/2007 (CPP-II))
