
1. Confirmation of minutes of previous IQAC meeting held on 26.07.2019

Resolution:

1. Dr R Praveen Sam, Coordinator, IQAC read the minutes of the previous IQAC meeting conducted on 26th July 2019. It was unanimously approved by all the members.
2. Principal informed the members that the orientation programme for I B. Tech has been organized in two slots ie 17th August 2019 for I B.Tech ECE & CSE students and 18th August 2019 for CE, ME & EEE students. Members appreciated this new initiation.
3. Principal informed the Heads of CSE & CE to apply for the MODROBS in connection with schemes notified by AICTE.
4. Principal informed that the college management has agreed to enhance the Internet Bandwidth from 50 Mbps to 155Mbps. Out of which 30 MBPS shall be distributed to Incubation Centre and the remaining 125 MBPS shall be utilized in the college campus.
5. Principal informed the members that the accreditation status granted by NBA to CE, ME & EEE programmes will be valid till 30th June 2020. But, as per the instructions given in the accreditation letter dated 1st December 2017, the accredited programmes should submit the Compliance Report at least six months before the expiry of validity of accreditation to be eligible for further processing of the accreditation status. In this connection, members discussed at length and decided that the three programmes namely CE, ME & EEE shall submit the compliance report to NBA for the extension of accreditation status. Principal distributed the hard copies of Compliance report formats to the Heads of CE, ME & EEE departments and discussed the points in the report.
6. Principal instructed the Heads, Deans and NBA Coordinators of CE, ME & EEE departments to initiate filling up the Compliance report and submit the draft of the same to the Principal's office by 16th October 2019.
7. Principal instructed the Heads & Deans of all departments that as soon as an activity / event organized by the department or by the faculty member of respective department is completed, they shall see that a detailed report be submitted to the coordinator, IQAC within one week from the completion of that particular activity / event.
